New Snapshot of Funding to Appeals

We have added a new snapshot of all funding to appeals on the FTS homepage. This snapshot allows you to see at a glance the overall requirements, funding, percent covered and unmet requirements for Consolidated and Flash Appeals. The link under the basic information in the box takes you to the global overview table (also accessible via the left-hand menu) with details per appeal.
