3. Important notes about the form

Due to the importance of tracking funding that has been made available for humanitarian response before and after the massive influx of people from Myanmar to Bangladesh that began on 25 August, we ask that you carefully read and follow the instructions below to the extent possible.

- In sections 4 and 5 below, please provide details on humanitarian funding for **Bangladesh only**, including funding that has been or will be pledged, committed or disbursed in the 2017 calendar year. In this form and in your statement, it is very important that you clearly announce funding for Bangladesh separate from funding for Myanmar (when possible).
- In sections 5a and 5b, please distinguish between funding before 25 August and public announcements, pledges, commitments or disbursements after 25 August. This will assist us to understand the amount of funding made available since the recent influx and the needs identified in the inter-agency plan.
- There is separate space in this form (sections 6 and 7) to communicate information about funding for Myanmar, including any new funding decided after 25 August. If possible, please indicate funding that has been specifically made available for Rakhine state.
- Finally, section 8 provides space to record funding that has been made available flexibly for Myanmar / Bangladesh since 25 August.
- Do not include general budget support or security aid. The objective of the conference is to capture pledges for immediate assistance for this crisis.
- Please **do not** include information about support provided during the 2016 calendar year. If you wish to report past humanitarian contributions that have not yet been recorded, contact the Financial Tracking Service (FTS) at fts@un.org.
- Pledge announcements will be reflected on the dedicated event website only after the pledging conference is officially closed (www.unocha.org/rohingya-refugee-crisis/pledging-conference).
